The mathematical economics curriculum covers all important areas of economics and the mathematical tools required for a critical, deep mastery of these areas.

The economics program curriculum emphasizes using an orderly way of thinking about—and solving—problems that can arise when making choices in situations that are beyond your direct experience. You'll study economic aspects of current events and public policy, microeconomic and macroeconomic analyses, economics in the context of specific sectors of the economy or economic dilemmas, global economic issues and more.
