I am a historian, consultant, and instructor of military professionals. As a historian, I am broadly interested in the experience of English-speaking military forces coping with the emergence of industrialized warfare in the West from 1880-1945. I examine the evolution of their organization, culture, operations, and techniques from many points of view. As a consultant, I support academics, civil servants, and service personnel in advising on national security matters such as controlling disruptive technologies in historical context. As an instructor, I employ historical decision games and Socratic discussion to encourage critical thinking, foster a culture of initiative, and promote interest in topics from air-ground cooperation to information operations. I am a history PhD student at Temple University currently working toward a dissertation prospectus for Prof. Gregory Urwin entitled *Building Bridges: US Military Engineers and Coalition Warfare in the First World War.* My vocation is service through teaching military history.

## WORK EXPERIENCE

# Gladstone AI, Research Associate, March 2023 - Present

I was the Lead Author for the historical survey for an AI action plan commissioned by the US State Department's Non-Proliferation Defense Fund (NDF) advising on the AI misalignment threat to national security. I identified a methodological framework of analysis and identified six disruptive emergent technologies from the 1860s – present and their regulatory regimes for case studies. The historical survey was a concise 60 pages written for key stakeholders across government and business sectors contextualizing the firm's Action Plan. Following the composition of the report, I took part in the first major US inter-agency workshop of its kind to discuss AI regulatory frameworks and cooperation. The historical survey was researched with open-source material.

# Canadian Forces College, Recurring Guest Speaker and PME Instructor, April – June 2022 & 2023

I researched, designed, and delivered a case method seminar to a senior class of the Canadian military's CFC's National Security Program (NSP) curriculum. This case entitled, *Army '86*, concentrated on a historical American strategic force development problem during the Cold War. Balancing political policies, emerging threats, and restricted resources in a complex and dynamic strategic environment, the NSP students assumed the role of the US Army Chief of Staff in the summer of 1983. The cases were taught virtually and on site.

# Maryland National Guard, Chief Archivist of the Witte Memorial 29<sup>th</sup> Infantry Division Archive and Hancock Library, 2018 – 2021

I preserved, and promoted the responsible use of, a substantial collection of historical material relating to the US 29<sup>th</sup> Division and the Maryland National Guard. In doing so, I have processed hundreds of inquiries, from both members of the public and public officials, related to the service of both units and individuals. I supervised and supported a project to digitize the holdings of this archive. I have led more than 70 tours through the museum attached to the archive for groups composed of people from many different walks of life. Additionally, I extended the mission of the archive to support the recruitment, retention, and readiness efforts of the Maryland National Guard. To this end, I embedded support for military learning into the formal plans that guided the work of the archive and introduced decision-forcing cases. Some of these cases, like those taught to the 1<sup>st</sup> Battalion, 175<sup>th</sup> Infantry Regiment, were conducted in classrooms. In others, such as the decision-forcing staff ride I led at Antietam for soldiers taking part in the Best Warrior Competition for 2020, it took the form decision-forcing staff rides conducted upon battlefields of the American Civil War.

# American University, Research Assistant to Dr. Audrey Cronin, 2018

I provided detailed research support to the composition of AU professor Audrey Cronin's book *Power to the People: How Open Technological Innovation is Arming Tomorrow's Terrorists* published by Oxford University Press in 2019. My specialization in conventional and unconventional modern industrial warfare was consulted for the opening chapters of the book which establishes the patterns of military technological development over recorded history and how this change exploded at the turn of the 20th century. The book explores the role of modern commercially available technologies in the hands of non-state actors in terrorism and insurgency operations. I assisted in proof reading drafts of the relevant sections and produced regular research reports to the author summarizing the historiographical arguments on military technology and technological determinism in warfare.

# Case Method Project Marine Corps University, Teaching Fellow, and Honorary Resident Historian, 2014 – 2018

I taught decision-forcing cases, on a wide variety of subjects, to students at the US Naval Academy, the Basic School, the Expeditionary Warfare School, and the Marine Corps Command and Staff College, as well as Marines serving in the Operating Forces. I assisted other case teachers with research, archival and otherwise, into amphibious operations, particularly those of the First World War and the South Atlantic War of 1982. I participated in *Antwerp 1906*, the recreation of a classic (double-blind) wargame exercise featuring an expeditionary force landing near a major fortified port city. I facilitated a case method seminar to our allies in the British Army's Education and Training Service at 1st Division H.Q. in York, UK and presented an article on the relationship between theatre strategy, the media, and morale to the Fall 2017 Inter-University Seminar on Armed Forces and Society entitled, *A War of Inches: The Effect of Wartime Journalism on American Troop Morale in the Italian Campaign, 1943-45*. Lastly, I contributed a chapter, "Rising to the Occasion: the U.S. Army Expansion in the World Wars 1900 – 1945," in Matthias Strohn's anthology, *How Army's Grow*.
